You have 2 options to access Minitab.

#### 1. Company provides limited licenses:

Below are the steps will follow for installation of this licenses

- PO number: 112549 while raising request
- Associates who are requires license needs to raise HUB ticket under
- TIM>> Sub categories>> Software Installation / Un-Installation>> TechM Provided Licensed Software (Charged back to IBG)>>
- Project manager(Rajendra Varma) will send mailer to <u>timcompliance@TechMahindra.com</u> with list of associates along with HUB ticket number for installation of Minitab for the period
- Based on approval and TAT, TIM compliance will approve ticket and further route it for installation of the same
- Software will be installed only on TechM devices (Laptop/Desktop) and they can use this software by TechM Lan or Wi-Fi (provided Wi-Fi enabled device)
